48th IISL COLLOQUIUM, 17-21 OCT. 2005, FUKUOKA, JAPAN

The 48th IISL Colloquium was held from 17-21 Oct. 2005 in Fukuoka, Japan. 56 papers had been accepted for 5 sessions. 10 papers were withdrawn, and 9 were summarized by others. The colloquium was well attended and discussion was good. The following sessions were held:

The 14th Manfred Lachs Space Law Moot Court Competition was held during the Fukuoka IISL Colloquium. The Case Concerning International Liability (Deltastan v. Gammaland) was written by Ricky Lee. Preliminaries were held at regional level in Europe, North America and in the Asia Pacific region. The Finals were judged by three Judges of the International Court of Justice. Prof. Kosuge and his efficient team of collaborators and the LOC organised everything very well. AWARDS

A **Distinguished Service Award** was presented to **Mr. Ricky Lee** (Australia), "With deep appreciation for his tireless service in support of the Manfred Lachs Space Law Moot Court Competition, and especially his outstanding leadership and contributions to the success of the annual Asian Regional Rounds".

The **Dr. I.H.Ph. Diederiks-Verschoor Award** was given for the 5th time in Fukuoka, to **Ms Zeldine O'Brien** from the University of Dublin, Ireland, for her paper "Consumer protection and the limitation of liability in the national regulation of the space industry". The board of review consisted of Prof. Back Impallomeni, Dr. Jakhu and Dr. Ospina. The Award consists of a medal and 500 Euros. A total of 3 papers had been submitted.

ELECTIONS

The Nomination Committee consisted of Prof. Galloway (chair), Prof. Monserrat and Dr. van Fenema. Dr. Perek had announced that he preferred not to stand for re-election. The Committee recommended that N. Jasentuliyana, E. Back-Impallomeni, G. Catalano-Sgrosso, S. Hobe, R. Jakhu, R. Ramirez, K-U. Schrogl, and P. Sterns be elected. It also nominated N. Jasentuliyana for President, in light of his continuing strong, energetic and progressive leadership of the IISL.

The Committee also proposed that the Board could achieve balance according to the 1/3 rule if the Assembly would choose by lot the newly elected directors to have either 2-year terms or 3-year terms. For 2005, five would have 2-year terms and three would have 3-year terms. To maintain balance over the years, the Board should fill any vacancies by selecting the new member not for 3 years but for the remaining amount of time in the vacated term.

The Assembly adopted the report by consensus.

3rd REGIONAL SPACE LAW CONFERENCE 2005, BANGALORE, INDIA, 26-29 JUNE 2005

This Conference, with the theme "Bringing Space Benefits to the Asian region", was jointly organised by the Indian Space Research Organisation (ISRO), the Astronautical Society of India (ASI), and the IISL. The meeting was held in conjunction with a Conference organised by the International Academy of Astronautics (IAA) on "Advances in Planetary Exploration", and several joint sessions were organised. Session topics were:

- Legal and technical implications of planetary exploration
- Legal aspects of launching services
- National space legislation: towards a Blueprint
- Remote Sensing and GI (Geographical Information)
- Telecommunications, including tele-education and tele-medicine
- A special case: Disaster Management
- Commercial issues involved with space activities

The Conference was very successful, with participants from 17 countries taking part. There has been a lot of follow up, especially in relation with the session on National space legislation. Interaction between lawyers and scientists was also very good. Reports of the sessions have been finalised and Proceedings are practically ready for publication early next year.

4th REGIONAL SPACE LAW CONFERENCE BANGKOK, THAILAND, 6- 8 AUGUST 2006

The Ministry of Information and Communication Technology of Thailand has agreed to host the next regional conference in Bangkok, Thailand, from **6-8 August 2006**. IISL will cooperate with the Space Law & Policy Centre of Chulalongkorn University in Bangkok, Thailand. This conference is the fourth in a series of regional space law conferences initiated in 2001 with the aim of bringing space law and policy specialists together in a specific region to discuss topics of particular interest to that region, thus allowing interested parties from various backgrounds to meet and interact with experts from all over the world and promoting mutual understanding and cooperation for the benefit of all parties.

The *provisional* topics to be addressed during the Conference are:

- Reforming the Regulatory Regimes governing **Telecommunications** in Asia

- **Regional Cooperation** in Asia relating to Space Activities (remote sensing, launching, satellite navigation, GI, training, ...)
- Legal aspects of **Disaster Management**: initial results and suggestions for improvement of the International Charter on Space and Major Disasters
- **Remote Sensing**: Legal aspects of direct access for private customers to hi-res commercial satellite imagery in Asia
- **National space legislation**: developments in Asia
- **Panel session** on legal issues arising from **space exploration and exploitation**
