Awards 2011

The IISL presented several [awards](#) to distinguished members of the space law

community during the Annual IISL Dinner last October.

Firstly, a Lifetime Achievement Award was awarded to [H.E. Judge Abdul G. Koroma](#), member of the International Court of Justice (ICJ), for his extraordinary career of more than 40 years in jurisprudence, diplomacy and international organizational leadership. In particular, Judge Koroma has faithfully served as a judge of the world final rounds of the IISL's Manfred Lachs Space Law Moot Court Competition since 1997, making him the longest-sitting judge on that final rounds court.

Secondly, another Lifetime Achievement Award was given to [Dr. Ernst Fasan](#) of Austria, in recognition of more than half a century of membership in and support of the IISL and the advancement of space law, which included being a co-founding member of the IISL in 1960.

Thirdly, an Award of Appreciation was presented to [Prof. Datuk Dr. Mazlan Othman](#) for her continuing interest in, cooperation with, and support for the International Institute of Space Law and its objectives, in particular as Director of the UN Office of Outer Space Affairs.

Fourthly, a Distinguished Service Award was handed to [Prof. Joanne Irene Gabrynowicz](#), Director of the National Center for Remote Sensing, Air and Space Law of the University of Mississippi, Editor-in-Chief of the Journal of Space Law and Director of the IISL, on account of her dedication to the interests of space law and the IISL.

Finally, [Mr. Scott Hatton](#) was presented with a Certificate of Gratitude for his continuing and diligent efforts as IISL webmaster since 2007, including the recent migration of the website of the Manfred Lachs Space Law Moot Court Competition.

The [Dr. I.H.Ph. Diederiks-Verschoor Award](#) for the best paper by a young author paper at the IISL Colloquium was awarded to **Ms. Irina Kerner** (Germany) for her paper on "*Supranational Space: Why the Powers of the EU are Not Quite Parallel.*"

Elections 2011

Election of Directors

At its recent General Assembly in Cape Town, South Africa on 5 October 2011, a number of positions on the [Board of Directors](#) of the International Institute of Space Law (IISL) were open for (re-) election.

As a result of the elections, firstly **Prof. Vladimir Kopal** and **Prof. Jose Monserrat** were elected as Honorary Directors, in recognition of their longstanding and very valuable contributions to the IISL over the past decades.

Secondly, **Mr. K.R.S. Murthi** (India; currently Senior expert in the Office of Advisor to the Prime Minister on Public Information Infrastructure and Innovations, and IISL Board Member since 2003) was elected as a new Vice President of the Institute. This is the first time that an Asian national holds a position as officer of the IISL.

Thirdly, **Mr. Dennis Burnett** (United States; currently VP Trade Policy and Export Control at EADS North America) was newly elected to the Board, in the position of Treasurer.

Fourthly, **Prof. Mahulena Hofmann** (Czech Republic; currently Holder of the SES Chair in Satellite Communications and Media Law, University of Luxemburg) was elected as a new Board Member, whilst **Prof. Elisabeth Back-impallomeni**, **Prof. Stephan Hobe** and **Prof. Frans von der Dunk** were re-elected to the Board.

IISL CONFERENCES AND EVENTS

54th Colloquium in Cape Town, South Africa 3-7 October 2011

The 54th IISL Colloquium included 5 sessions addressing the following topics: (1) Nandasiri

Jasentuliyana Keynote Lecture on Space Law & Young Scholars (2) Legal issues of commercial human spaceflight (3) Africa: Space Law and Applications - Past, Present, and Future (4) Environmental Aspects of Space Law and of Space Activities (5) Recent Developments in Space Law.

In addition, the 26th IAA-IISL Scientific/Legal Roundtable was held on the topic "Space Debris Environment Remediation," and reflected the results of the completed International Academy of Astronautics (IAA) Cosmic Study chaired by H. Klinkrad and N. Johnson. The IISL also organised a joint session with the IAF on 'Legal Framework for Collaborative Human Space Missions'.

20th Manfred Lachs Space Law Moot Court Competition

The 20th [Manfred Lachs Space Law Moot Court Competition](#) was successfully concluded at the recent International Astronautical Congress (IAC) in Cape Town, South Africa, 3-7 October 2011. In doing so, the competition was once more confirmed as the only moot court competition on issues of space law which is globally recognized and enjoys broad participation.

The [World Finals](#) on October 6, judged as always by three Judges from the International Court of Justice (ICJ), Judge Koroma, Judge Tomka and Judge Xue, resulted in a victory of the team of Florida State University, winner of the North-American round, over the team of the National University of Singapore, winner of the Asia-Pacific round. The University of Saint Petersburg, winner of the European round, finished third in the competition, in which overall 42 teams participated.

In addition, an African Introductory Round was held with three teams participating, from Mount Kenya University of Nairobi, Kenya; Obafemi Awolowo University of Ile-Ife, Nigeria; and the University of Pretoria, South Africa. The team from Obafemi Awolowo University emerged as the winner.

The success of the African Introductory Round also means that as of the current academic year, an official fourth preliminary round will be organised in Africa.

The IISL is very grateful to the Moot Court Committee, led by co-chairs Dr. Mejía-Kaiser and Dr. Tennen, for their tireless efforts in safeguarding and strengthening the excellent

reputation of the competition, which celebrated its 20th anniversary in Cape Town.

IISL/ECSL Symposium at COPUOS, 19 March 2012

On the occasion of the 51st Session of the Legal Subcommittee of the UN COPUOS in March 2012, the IISL and ECSL will organize the annual Symposium for delegates of the Legal Subcommittee. The topic for 2012 is "Transfer of ownership of space objects: Issues of responsibility, liability and registration". The presentations of the previous Space Law Symposium on "A new look on the delimitation of airspace and outer space" are available on the UNOOSA website. The papers of these symposia will be published in the IISL Proceedings.

Toulouse Space & Law Forum, France, 25-28 June 2012

The [Toulouse Space & Law Forum](#) is an initiative of CNES, the Midi-Pyrenees Region and the University Toulouse1-Capitole. The IISL will co-organize the space law sessions. The Forum focuses on the legal aspects triggered by the whole chain of service providers, from the spacecraft to the end users. It will provide a forum for presentations and discussions of the latest research results and practical applications and will stimulate interdisciplinary and international collaboration.

The key areas which will be addressed during the conference include:

- Legal constraints: rights, freedom, privacy protection,
- Licensing requirements for space activities:

- national laws, regulatory regimes and international treaties,
- Space activities, private agreements and public procurements,
- Space ventures and financing opportunities,
- Lessons from emerging countries,
- Intellectual property rights,
- Responsibilities of service providers, data suppliers, users and other players,
- Evidence from space: use of satellites data as legal evidence,
- Service providers' obligations.
